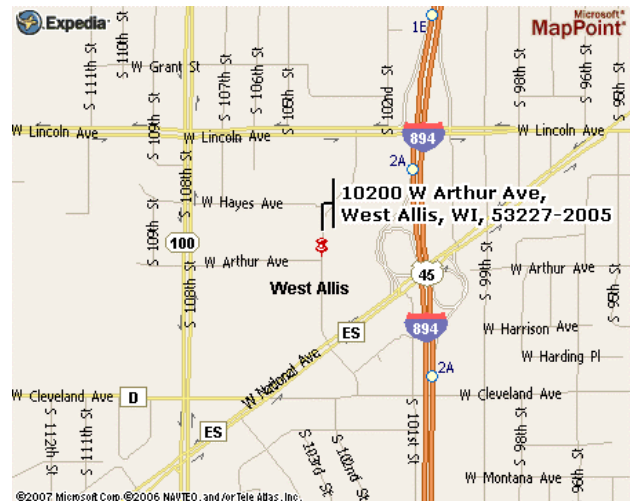
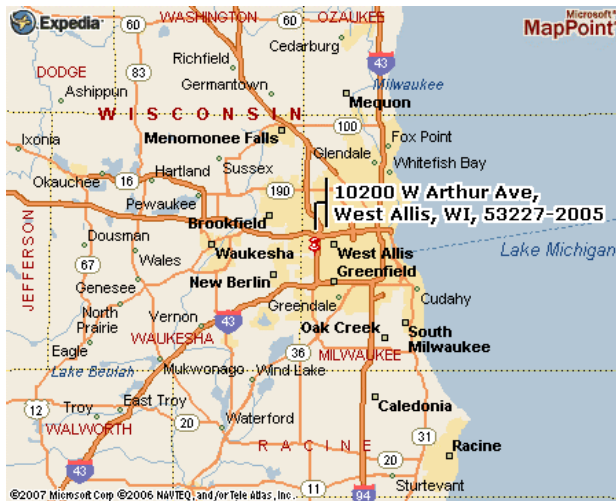


NCCC MEMBERS MUST PRESENT A CURRENT NCCC MEMBERSHIP CARD TO EARN NCCC POINTS
