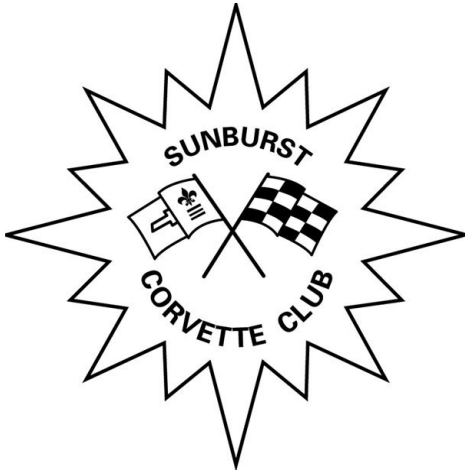

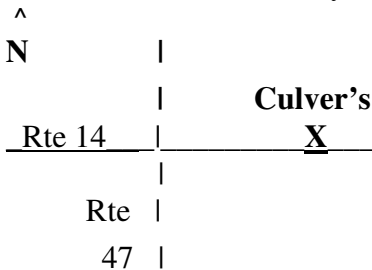

(If you're going to eat dinner, you'll save money by pre-registering)

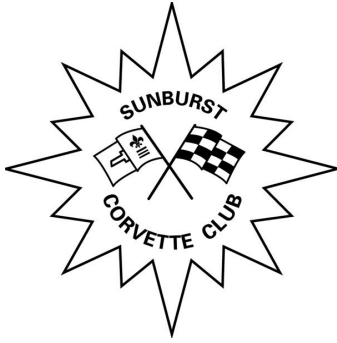


**Start Place:** stub street in front of Culver's - Woodstock
