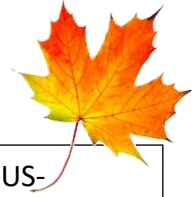

Directions



From the North: Take I-294 South to I-55 North. Take the next exit (279A) for US-45/LaGrange Road South. Follow LaGrange Road South to 159th Street. Turn left on 159th Street (East). The Mickadoon's at Orland Bowl will be on the right just before Apple Chevrolet.

From the South: Take I-57 North to I-80 West via Exit 345B toward Iowa. Take route 43/Harlem Avenue North via Exit #148. Follow Harlem Avenue North to 159th Street and turn left (West). Follow 159th Street. Mickadoon's at Orland Bowl will be on the left just after Apple Chevrolet.

From the East: I-80 West to route 43/Harlem Avenue North via Exit #148. Follow Harlem Avenue North to 159th Street and turn left (West). Follow 159th Street to Mickadoon's at Orland Bowl on the left just after Apple Chevrolet.

From the West: I-80 East to the US-45/LaGrange Road North exit via Exit #145. Follow LaGrange Road North to 159th Street and turn right. Follow 159th Street to Mickadoon's at Orland Bowl on the right just before Apple Chevrolet.
