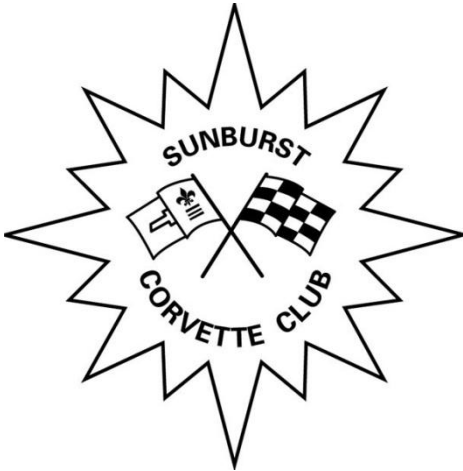

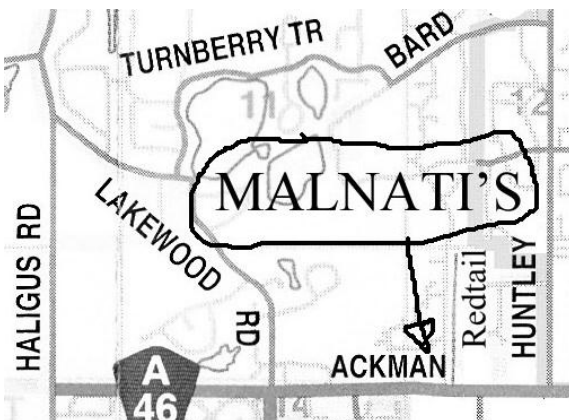

Same-day registration: \$30 /person includes: registration, dinner, beverage, dessert, gratuity, prizes.

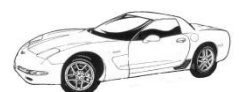


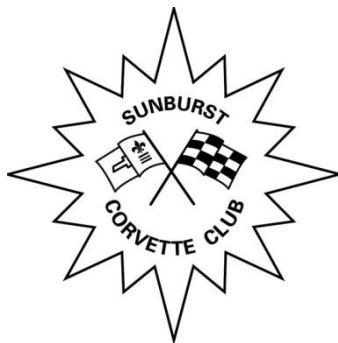
