Driving from the North? The Quarters in Rantoul (1 hour from Mattoon) is an option for Friday. Call 217-893-1234

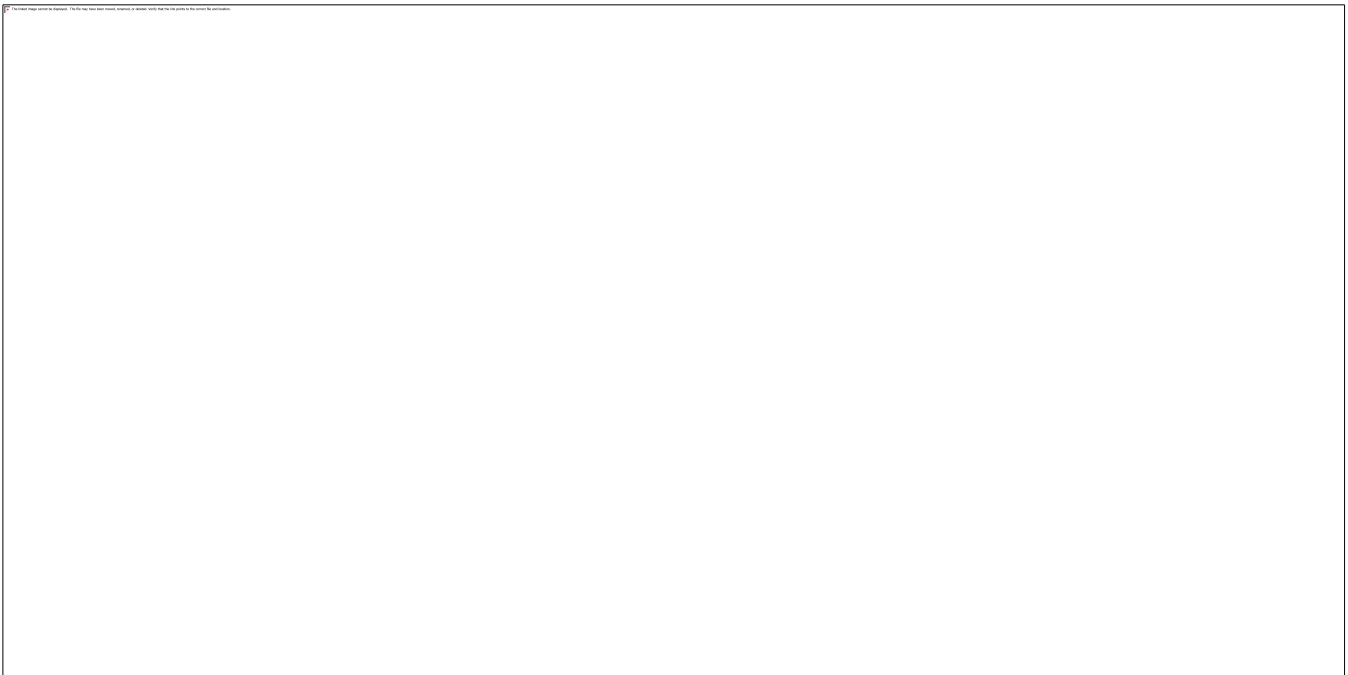
Coles County airport is located about 1 mile east on Illinois Route 16 from I-57. Turn right at airport road after passing the BP Gas Station. Keep to your right to the parking area. The award winning Airport Steakhouse is in the terminal building and it will be open for breakfast, lunch and dinner. Please park trailers to maximize our parking area. Trailers may be left at the airport Friday until Sunday.

Cody's is a Western Steakhouse style restaurant with peanut shells on the floor, beverages, and good food. Just west of I-57, turn right at the Marathon Gas Station and right again at the stop sign.

The Comfort Suites, Baymont Inn and Hampton Inn are within walking distance. The Holiday Inn is across IL Rt. 16.
