#### Regional Executive (RE)

- This position is the Chief Executive Officer of the Region.
- Is responsible to call and preside at a minimum of one meeting per calendar quarter for the purpose of conducting Regional business.
- Is responsible for writing articles three times per year for Blue Bars Publication.
- Required to attend the RE meetings at the National Board of Governors meetings.
- Responsible for seeing that all clubs are represented at the National Board of Governors Meetings either by having the club present or using the proxy of the club not in attendance.

### Regional Competition Director (RCD)

- Is responsible for the conduct of the sanctioned competition events within the region.
- Is responsible for the maintenance of all official NCCC results and standings for the region.
- Required to attend the RCD meetings at the Board of Governors Meetings.
- Performs the duties of the Regional Executive in the absence or disability of the Regional Executive.

 Schedules the Annual Sanctioning Meeting.

### . Regional Membership Director (RMD)

Responsible for the promoting of membership in NCCC for the region. Is responsible for distributing the required NCCC membership literature and answering all questions regarding membership from interested persons within the region. Required to attend the RMD meetings at the National Board of Governors Meeting. Performs the duties of the Regional Executive in the absence or disability of the Regional Executive and Regional Competition Director.

### Regional Secretary

 Is responsible to take minutes at all regional meetings and forward these minutes to all the governors within the region along with copies to all officers of the region. Tapes of the meetings for the last twelve months will be available at all regional meetings. All meeting tapes are to be held for a minimum of three years. The tapes and records are to be kept by the regional secretary. Attendance is requested at the regional meetings when held in conjunction

with the NCCC Board of Governors meetings.

### . Regional Treasurer

- . Responsible for all monies collected by the region.
- . Will issue a treasurer's report for all regional meetings.

- . Responsible for handling officer expenses except travel.
- . Attendance is requested at the regional meetings when held in conjunction with the NCCC Board of Governors meetings.

All regional officers, if in attendance at the Board of Governors meeting, are paid for mileage expense one way based on a central point of the region at the rate of \$ 0.25 per mile. Regional Treasurer and Secretary will only be paid if in attendance at the regional meeting held in conjunction with the NCCC Board of Governors Meeting. Travel expense is not allowed for any officer when meetings are held within the region.


YOU STILL HAVE TIME TO QUALIFY FOR THE MIDWEST REGION CHAMPIONSHIP SERIES!

\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*

The sanctioned competition events which are listed on the Midwest Region Event Calendar are the events which are used to accumulate "points" towards qualifying. The individual "points" are accumulated from January 1st through September 10th. In addition to the number of points required to qualify in each event type, a person must have entered a minimum of five (5) events during that time period. Please note that no travel, worker, or Chairperson points count; a person may receive one event participant credit for the event in which he/she was Chairperson or Co-Chairperson. A person may qualify in more than one class in Concours or Speed but must declare only one class when registering to participate in the Championship Series events. Points needed to qualify for the types of events are:

- \* CONCOURS -- the points must all be earned in the same class; the number of points varies according to class. Wash & Show - 12; Street Show - 16 points; Concours Prepared, Modified, Custom, or Race Prepared - 20.
- RALLYE -- 12 points both driver and navigator must be qualified.
- SPEED -- 25 points the points must all be earned in the same class. Points for a Matching Time Trial count only if held in conjunction with a speed event. (Funkhanas and Drags do not count.)

There are still a lot of events that can be attended so you can be qualified. In the middle of September people who are qualified will receive an invitation in the mail to participate in the Championship Series. The information regarding the series is enclosed in this newsletter.

# FROM THE RCD

Summer is well upon us and the competition season is under way. Included elsewhere in this newsletter you will find a partial points standings and a competition schedule for the rest of 1995. I hope you've taken time to try an event or two this year, but if you haven't, there are still plenty of events.

Mark September 23rd and 24th on your calendar - that's the date of the Midwest Region Championship Series. This weekend will include a concourse, a rally, a low speed event, and a party (a flier is included in this newsletter). You must be qualified and invited to participate in the competitive events, but everyone is invited to spectate and to the party. To qualify and be invited to the competitive events you must participate in minimum of five events (of any type) and earn a minimum number of points in a given class (See the last edition of the Midwest Region newsletter or your club Governor for details). There's still time, so why not give it a try??

By the time you are reading this, another years NCCC Convention will have passed. Nest years convention will be held in Orlando, Florida and the 1997 convention will be held in the Cleveland, Ohio area. Why not try to schedule a summer vacation around a Corvette convention? You will be

exposed to a weeks worth of competitive events, including a concourse, high and low speed autocrosses, drag races, and a rally. Every night there is a party and themes usually include a 50's/60's night, western night, etc. If you've never attended an NCCC convention, you're missing a great time.

As Midwest RCD I sit on the NCCC competition committee along with thirteen other RCDs and the Vice President of Competition. Over the last three years we have worked hard on a new rulebook that should be ready for 1996. The book has been completely rewritten in a much more organized fashion. For the autocrosser there will be a new "Street tire" class that will allow you to compete equitably on "real" For the clubs hosting street tires. concourses, we have a new type of show called a "Peoples Choice" show. This will allow clubs to host a corvette show without all the work and judging that's involved in a normal concourse. Entrants and spectators would be allowed to vote for their favorite car in each class. Many hours have been devoted to this entire project and I think you will like the end product.

That's all for now - I hope to see you at some of the upcoming events this year.


