The 1989 NCCC Midwest Region Competition Season is now over. In addition to the year-end awards and banquet, one other item remains to be done; that is to distribute a final 1989 Points Standings to you, the Governors, for comments or corrections. According to the Midwest Region SOPs, you have ten (10) days to send any corrections to me; after, that, they will be considered final. A tentative Final Points Standing is enclosed.

1989 was a busy season and was the second biggest year ever for the Midwest Region (1988 was the biggest). The average number of entrants per event was virtually the same as for 1988, but the total number of events was down somewhat. Some data for recent years follows:
