### **Approval of February Region Meeting Minutes**

February 23, 2019 MWR Governors Meeting minutes were e-mailed to officers and governors on March 16, 2019. Requested motion to approve the minutes as e-mailed

Convention Committee Update. Jeanne Cassel - The convention committee met on Saturday night. All is on track for Denver Colorado's 2019 Rocky Mountain High Convention. There is still opportunity for rooms, and to enter events, including the Golf Olympics. The 2020 convention plans for Indy are underway. The Convention Committee is looking for a 2021 proposal. 2021 discussion suggestions included NCCC do the convention as a group, and discussed contacting and contracting with a private convention planner. The committee is open to receiving ideas for possible convention sites. A full proposal is not required to start discussions.

### <u>MWR Treasurer Reports – Bill Docherty</u> – <u>Contact your Governor for included Financial Document</u>) Report on region finances – I/E Report, I/E Trend chart.

The <u>Midwest Region Financial Summary Report – Period Summary and YTD Summary</u> reports were reviewed. The financial pages included with these minutes reflect the math adjustments discussed at the meeting. Closing items from 2018 books, including the carryover of 2 checks from 2018 that were reissued in 2019

- The MW Trend information and Graph as of May 4, 2019. The income dip is because this is early in the year; fundraisers are yet to run. Bill mentioned that as we take the next year budget vote at the November meeting, we will know the fundraiser expense so will know what can be spent on awards and any party subsidy. Gary Kelly noticed that the graph labels/names have disappeared and are showing as "series". Bill will add them and will have an updated version for the communication.
- The 2-page NCCC-Midwest Region 2019 Budget Plan depicts Income and Expenses and compares Budget to Actual. Notes are in the right column. Awards Misc Income is from members who bought extra awards. Party expenses are depicted. Governors were reminded to support the Fundraiser if we want a good party; the alternative is the head tax.

# **Report from RMD meeting**

NCCC has 17,867. The Midwest Region is the largest region with 27 clubs and 2,484 members, of which 81 are new MW Region members. MWR had 27 MAL and 26 Lifetime members, and 1 new Youth Member. Corvette Club of

Illinois is the largest region club with 207 members. Three membership cards were returned for address correction; if not corrected, these members will not get mail.

Question was asked regarding electronic signatures on NCCC Applications. Are electronic signatures on Applications allowed? Joan Thomas said she received an OK from the Post Office. Sandy will take the question to the RMD meeting.

### MWR-RCD Report - Ray Bair

### **Report from the RCD Meeting:**

Rule book was reviewed and there was discussion on tire sizes. The 2018 Rule Book is in effect, not the "Red Line" version. No changes other than things mentioned at last meeting.

The Helmet Sticker was rolled out. There was discussion on the timing of the helmet expiration when a mm/yyyy date listed is mid-year. Decision: A helmet expires on the expiration date, or end of year if no mm/yyyy date specified. A sticker is not available for a partial year.

- The April 14th rally was cancelled due to flooding in Milan. It is actually worse now.
- oThe Pekin Weekend went well. We may be back there.
- oLooking forward to the Columbus and Rantoul events. Check e-mail for updated information on events.
- **Memorial Day Fundraiser status** all is good. 21 events and at hanger 2. Tk's Cheesesteaks Food Truck will be there Saturday & Sunday, Monday, maybe Pizza. The plan is to start the event earlier in the day. It will be a competitive weekend as 4 regions are also doing 21 event weekends.
- October Region Fundraiser Status Not absolutely sure of Rantoul so are hedging with Pekin. Windy City transferred the application to the Region.

So far our events are good on flyers – through July. This year there are a ton of Rallies. This is a good way to introduce people to club activities. Car Shows will be starting as weather improves.

Concours – Florida Region brought a Rule Book change proposal to the RCD meeting. Discussion centered on having 7 judged Concours in a day and not enough hours in the day to judge them. Possibilities – limit the number of events per day, or have different or separate judges for each event.

Jack Wilson asked about a published notice regarding changes to Grand Sport class. Ray said it is in NCCC minutes, and nothing is posted yet. C7 Grand Sport went from 'N' to 'M' for Autocross. High Speed it was already in 'M'. Question also asked clarification for Drag Events with convention coming soon. Dale Samuelson said if nothing is posted, a change doesn't exist. Ray will discuss communications with Joe. The Rule Book information has to be communicated.

  - We received 11 tire certificates this year. Five certificates will go to convention, one to scholarship fundraising, and one for FCOA fundraising. Three certificates will be raffled at the next meeting
     The new FCOA director is to be announced at today's national meeting.

oFinance Committee report was good.

- Grants and Scholarships are in good shape, but can always use additional funding support.
- Ecklers is a solid sponsor; Mid America is not a sponsor at this time.
- 2019 Denver Convention attendance is at 400.
- 2019 Membership Cards cost \$15,400 which is under budget by \$4,000
- St Jude fiscal year for fundraising is May 1 to April 30.
- o There are 5-6 minor bylaw changes—they basically are housekeeping. Larry will send an e-mailed draft out later. Vote will be for next year.
- Region Recognition submissions? Larry Pagliaro explained the program and mentioned he has received nice comments from members who have been recognized. This member recognition is for non-club related service. Get the information about club members who you'd like recognized to Larry before the Blue Bars deadline.

- St Jude charity coordination discussion Sandy Arnold.
  - oLarry started the discussion by explaining the poll he sent out about St. Jude. The poll crashed and burned; vote was 50% yes, and 50% no. It appears there may have not been enough information for governors to make an informed decision as many did not vote.
  - oSandy explained that the St. Jude Drive-out was initially started by her club. Problem is that now she is the RMD and is uncomfortable being the 'customer base' or info source. As RMD it isn't appropriate to give the appearance of soliciting or selling the event. The poll question asked if we need an area representative for the St. Jude Drive-out. Sandy is willing to bring flyers but doesn't feel she can 'do the drive'. Michele Cantelmo will be the central contact point. NCCC has ambassadors to St Jude. Sandy offered to be the ambassador. Putting something on the MWR website to pitch for events was discussed, but as this is national, a flyer on the NCCC website would be better.
